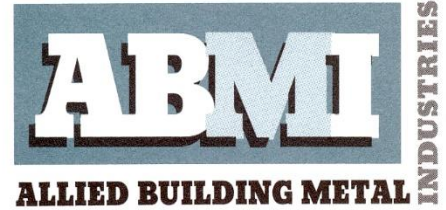

**RULES**

1. The Allied Building Metal Industries, Inc., Ed Simpson and Jack Daly Iron Worker of the Year Awards Program is open to all full-time Iron Workers employed by a member firm of Allied Building Metal Industries, Inc., or by a contributing employer to the industry's advancement funds. Nominated Iron Workers must be members in good standing of either Structural Iron Workers Local Union Nos. 40 or 361, or Ornamental Iron Workers Local Union No. 580. Paid officers or agents of the above labor organizations are ineligible for nomination. Awards will be given in five distinct categories: new and renovated bridges; new buildings; building renovations; miscellaneous metal projects; and architectural and ornamental metal projects.
2. Awards will be made to eligible Iron Workers who, with respect to a single project or series of projects in one of the above categories, exhibit leadership, ingenuity, an awareness of safety, innovative techniques and/or work practices, craftsmanship, or similar attributes. Projects must be located in the geographic areas covered by Iron Workers Local Unions Nos. 40, 361 and/or 580.
3. The Iron Worker of the Year Awards Committee reserves the right to interpret all rules and regulations regarding the Iron Worker of the Year Awards Program; any decision made by said Committee is final and irrevocable. Each Iron Worker of the Year Award nominee and nominator must be willing to accept the decision of the Iron Worker of the Year Awards Committee as final and binding.
4. Only employers as described in paragraph one above may submit nominations. Iron Worker of the Year Awards will be limited to one employee per nominating employer. Employers interested in submitting a nomination may obtain the requisite forms by contacting
